The Innovation Fund of the Republic of Serbia (IF) intends to engage **minimum 10 experts** in the capacity of Investment Committee Members for three Investment Committees, as stated below:

-  **5 experts** in the capacity of Investment Committee Members for the Mini Grants Program in following areas of expertise: private industry, international entrepreneurship, international finance and venture capital / private equity, business development; and **3 experts** in the capacity of Investment Committee Members for the Smart Start Program in following areas of expertise: private industry, international entrepreneurship, international finance and venture capital / private equity, business development. The IF reserves the right to engage 3 persons from the pool of 5 members of Mini Grants Investment Committee members for evaluation of applications under the Smart Start Program.
-  **5 experts** in the capacity of Investment Committee Members for the Collaborative Grant Scheme Program in following areas of expertise: APPLIED RESEARCH, INTERNATIONAL ENTREPRENEURSHIP, PRIVATE INDUSTRIAL SECTOR, INTERNATIONAL FINANCE AND VENTURE CAPITAL/PRIVATE EQUITY.

The experts will be selected in accordance with the procedures set out in the IF's general Rulebook on procedures for selection of independent international experts for the purpose of implementation of the IF's financing programs (March 2017) and awarded contracts for individual consultancy services.

Interested and eligible candidates for the positions of Investment Committee Members should send expressions of interest, by e-mail to the contact information listed below.

Expression of interest should be sent together with information on relevant experience and CV. Candidates should clearly state for which of the Investment Committee is applying: either (1) Investment Committee for the Mini Grants /Smart Start Program or (2) Investment Committee for Collaborative Grant Scheme Program.

Award criteria: (1) General work experience – up to 30 points, (2) Specific work experience – up to 40 points, (3) Number of investment panels participated – up to 30 points.
